Treasurer's Report - Annual Accounts 2019 - 2020

In spite of several challenges during the year it is pleasing to again report a small operating surplus of income over expenditure for the year. The table below summarises the detailed accounts which follow.

This year **Income** was bolstered by two significant grants as well as donations. Pub Charity King Country area contributed \$10,000 towards our Ruapehu insurance premiums and The Trusts Community Foundation from West Auckland again supported us with a grant of \$3,779 towards the insurance premium payable on our Waitakere Hut.

To both organisations we are most grateful. Also a big thank you to Chris & Pat Barfoot's \$640 donation from the sale of their book "Show Me A Huiā" which contains many references to ASC activities, to Graham Russell for his \$500 donation and to the many other club members who included a donation with their annual subscription.

Sadly Ruapehu hut fees from members and guests dropped away quite considerably (refer table) but we were again most appreciative of the Got to Get Out organisation making good use of the Ruapehu Hut. Income from Waitakere hut fees again fell short of the normal \$9000 expected due to the kauri die-back issue, which has deterred both members and outside groups from staying at our hut.

Subscription income surprisingly remained on a par with previous years.

On the **expenditure** side the Club's outgoings remained reasonably consistent with previous years.

The operating accounts for both the Ruapehu lodges and the Waitakere Hut as detailed in *Table B* do not include the grants towards this year's insurance premiums, as referred to in the income paragraph above. Instead these grants have been included in the main income section under Donations and Grants which is consistent with the way we have treated charitable grants in the past. This ensures that the reporting of Lodge returns are comparable year on year.

Due to the Covid-19 shut down it is doubtful that income will be available from these sources this year.

Normal operating expenses at Ruapehu continue to escalate as will be seen from *Table B* in the Accounts.

Expenditure for the Waitakere Hut is quite modest (*Table B*) and varies very little from year to year. Last year, as a result of our submission, based on the fact that the Rahui placed on the surrounding tracks had reduced our hut usage and resulting income, Auckland Council refunded the rates which we had paid. Unfortunately this policy was not continued by Council this year so we have had to meet the full cost of rates.

Club communication, club evenings and administrative costs (*Table A*) are consistent with previous years, including Alpinesport costs where only five issues were published compared to the eleven issues published annually for most of the preceding 90 years.

The challenges of the year ahead remain unchanged to those listed in my last year's report which were:-

- 1) to **increase membership**, which is best done by existing members introducing their friends and acquaintances;
- 2) to work with Auckland Council to ensure that **tracks in the vicinity of our Waitakere Hut are reopened** so that outside groups can make use of our hut for overnight stays. John McKay is working with Regional Parks on this.
- 3) to **increase occupancy** of our Ruapehu A Frame Lodge and Ruapehu Hut.



At last year's AGM members agreed by a 75% majority that the Ruapehu Hut should be disposed of and that until that occurred the hut should only be insured for the demolition cover and site clearance of \$250,000 as required under the terms of the lease. Unfortunately our insurers withdrew their demolition-only cover offer two days before roll over and we had no option but to reinsure for full value for a further year. The new committee then decided that the Ruapehu hut should be retained as they were determined that membership numbers could be increased so that the operational loss would gradually reduce. So far this anticipated increase has not eventuated.

On a more serious note the Club has a contingent liability under the terms of our lease to either insure for, or have cash resources in reserve, of \$250,000 per building to cover the cost of hut removal in the event of the buildings being destroyed or the club abandoning them. It is for this reason that the Club has retained a significant cash reserve to help fund this liability. When I took over as treasurer, cash at the bank was \$99,800. It currently stands at \$134,700. During this period the A frame has been re-clad, the aluminium windows replaced, the roof repainted and extensive renovations undertaken to both Ruapehu lodges all at some considerable cost. The main outstanding issues to attend to are the repair of the A Frame balconies, attach the battens to the A Frame plywood cladding and paint or stain the exteriors of both buildings.

The purpose of holding \$100,000 in the bank is to increase the insurance excess on both Ruapehu buildings in

return for a significant reduction in our insurance premiums, and therefore in our fixed costs.

The Covid-19 pandemic will certainly have a significant financial impact on Ruapehu usage this coming ski season – to what degree, who knows but it will be a challenge. *It will require prudent budgeting and management* to ensure that both the fixed costs and the variable costs, which were \$80,000 last year, are covered.

Finally this year completes my eleventh year of this, my second term as treasurer. My first term commenced back in 1967, during the building of the A Frame, and included several years of assisting with fund-raising to repay both the bank loans and Club debentures which were used to fund the lodge. In those days there were no computers, subscriptions were paid either in cash or by cheque and recorded manually for 500 plus members as part of the treasurer's role. How times have changed.

For the past ten years I have represented the Club on the **Ruapehu Mountain Clubs Assn** where I have also been the Association's treasurer. This year I plan to step down and make room for someone else to contribute to this organisation. The RMCA plays a very important role on behalf of all clubs on the mountain so I do hope that Alpine Sports Club will nominate another candidate to stand for election in my place.

E. NOTES TO FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2020

1 Accounting Policies:

(a) Reporting Entity

The reporting entity is an incorporated society.

(b) Measurement Base

The accounting principles recognised as appropriate for the measurement and recording of the financial performance, cash flows and financial position on a historic cost basis are followed in the preparation of the financial statements.

(c) Specific Accounting Policies

1) Subscriptions are recognised as income in the year to which the subscription applies.

2) The cost of Fixed Assets have been traditionally written off over their economic lives as follows:

Club Huts	- 40 years
Fixtures, Fittings, Carpets	- 10 years
Whiteware & Electrical Items	- 5 years
Computer Hardware	- 5 years
Outdoor Equipment for Hire	- 5 years

In 2012 we stopped deducting depreciation on the Club huts as the book value no longer reflected a realistic valuation of the huts and there was no purpose to be served in continuing to write down their value against operating income. If it was decided to dispose of these assets at some stage in the future then the book value shown in the accounts will be written off against Members General Funds.

3) The value of voluntary services and club hut use by work parties is not assessed and brought to account as a cost in the Accounts.

4) The G.S.T. exclusive basis of accounting is used.

2 Fixed Assets

5) The Club Buildings are revalued every two or three years for insurance purposes. The following is a comparison of cost, valuation & insurance cover. These figures exclude GST.

SEPTEMBER CLUB NIGHT

Peter and Margaret Jemmett's trek to Everest Base Camp and the Three Passes

Well that was the plan! In 2018 Margaret and I prepared for our trip to Everest Base Camp and the Three Passes.

We embarked on a fitness program and with the Waitakere's effectively closed we set our sights on Mt Te Aroha, Mt Karangahake, all over Great Barrier Island and in between we walked the streets. We check out the sights of Kathmandu, the food, shops, traffic and the people. We fly to Lukla where our trip really starts and we find out if all our preparations have been enough.



Paparoa Great Walk - March 2020

The brand new Paparoa Great Walk was written about for a long time before its opening date of 1st December 2019. But fate has dealt it a cruel blow. Our group of four had booked the huts many months earlier for March 2020. Sadly it will have been open for only 3 weeks in its first 10 months. We felt very lucky.

We began at the Punakaiki beach and into the Pororari Gorge, with its high limestone cliffs each side of beautiful rainforest and tannin stained pools in the river. After a

half hour the bike trail joined in and we trekked through level bush, passing the track which leads to the Cave Creek tragedy. Prince of Wales ferns along the way showed how wet it can get, and later we began the slow ascent towards the new Pororari Hut. As the track is a shared trail like the Old Ghost Rd we had the company of many cyclists, some fit enough to go through in one day. The trail is of such a high standard, with metal and rock slabs, there were only about 5 metres of mud in the whole 53km track. And that is the

wet West Coast! The hut and track makers have done a tremendous job in often trying conditions.

There were extensive views from the hut towards the Tasman Sea and over the Punakaiki valley. New warm huts are supplied with solar lighting and even USB chargers for phone cameras. Also we slept on the most comfortable mattresses I have ever slept on in the hills. Bikers were no problem as they disappeared in seconds.

A misty morning greeted us as we had a gentle climb on switchbacks - for the cyclists - through beech forest, passing stunning waterfalls to gain the top of the escarpment. Alpine scrub and steep cliffs exposed the limestone and black coal seams. Intriguing to note kilometres below us was the infamous Pike River Mine. A track is being cut off this one to the mine entrance. Our track has been built as a memorial to that disaster which killed 29 miners.

We traversed along the escarpment, meeting many people

going the opposite way - which was what most did. Parts went through dracophyllum forests with lots of alpine flowers about including many gentians. The Moonlight Tops hut was gained late afternoon and has stunning views way below to the coastal surf beaches.

Our final day cleared to a blue sky wonder with tussocky alpine scrub along the main Paparoa range with views to the Mt Cook area and Arthurs Pass mountains. Soon after chatting to a passing Kathmandu photo crew we came down to the old Cecil Clark hut at the bushline. This is part of the old Croesus track from Blackball crossing to Barrytown on the coast. Lunch was had amongst the DOC hut renovators then a quick look at the very old Top Hut nearby before a gentle descent in the bush giving encouragement to the cyclists pushing their bikes uphill.

The final hour was spent passing the old gold mining sites from the 1890's. At the large carpark our Paparoa Shuttles driver waited patiently for these slightly late oldies. But everybody finished with big smiles on their faces. With earlier cyclones and slips and covid lockdowns starting soon after we finished, we felt lucky to have made our booking when we did. The track reopens again on 1st October.

OBITUARY - REMEMBERING NEIL PALMER

He was often seen standing at the AUTC notice board planning and discussing trips with other trampers. For the AUTC reunion in 2012 his viola skills were put to good use in providing music for the social activities.

Neil joined ASC in the early 1970s and involved his family in Family Camps and other tramping activities as they grew up. He had a wonderful manner with children and we have lovely memories of his gentle, friendly leadership as he played his guitar for the evening singalongs.

His other passion was playing the viola. He started learning the violin in Form 1 and switched to playing the viola at the age of 17. From then on he enjoyed playing with his twin, Alan, on violin and his friend Jim Brown on piano. He played in the Auckland Secondary Schools Orchestra, then progressed to the Junior Symphony Orchestra, the Auckland Symphony Orchestra, St Matthews Orchestra, Mozart Orchestra, chamber groups and always informally with Sharyn and the family.

At the time of his death Neil was a valued member of the Philharmonic Society Orchestra and was a keen member of the U3A music group, bringing to it his extensive musical knowledge.
